

# Nagoya University of Foreign Studies Activity Guidelines

2022. 1. 17

◦In order to respond appropriately to requests from the government (the national government or Aichi Prefecture) for countermeasures against the novel coronavirus, Nagoya University of Foreign Studies shall establish guidelines for its activities.

◦The decision on the level of activity will be made by the Nagoya University of Foreign Studies coronavirus Task Force Committee, and will be reviewed as appropriate based on the content of the request from the administrative body and the infection situation inside and outside the university.

## I Level

Level	Judgement Guidelines for Activities (Applicable to cases where at least one item applies)
Level 0 Normal	There is little risk of infection in the community.
Level 1 – Caution	Low risk of infection in the community
Level 2 – Alert	<ul style="list-style-type: none"> <li>◦There is an increased risk of infection in the local community.</li> <li>◦There have been sporadic cases of infection within the university, but not to the extent of affecting all university activities.</li> <li>◦The national or local government has issued infection prevention measures, requiring universities to further strengthen their infection prevention measures.</li> </ul>
Level 3 – High Alert	<ul style="list-style-type: none"> <li>◦The number of infected people is rapidly increasing in the local community.</li> <li>◦The number of infected people on campus is increasing rapidly, and effective measures to prevent the spread of infection need to be taken immediately.</li> <li>◦The national or local government has issued infection-prevention measures, requiring the university to further strengthen infection-prevention measures.</li> </ul>
Level 4 – Emergency	<ul style="list-style-type: none"> <li>◦The number of infected people in the community is increasing rapidly.</li> <li>◦The number of infected people has spread rapidly in the campus and drastic measures to control the infection need to be taken.</li> <li>◦Requested to close by the government or local authorities due to the emergency declaration.</li> </ul>

Research activities at home are encouraged.	To prevent infection, only some activities are allowed. For details, please refer to the Extracurricular Activities Guide.
